When in doubt, leave it out!

DO NOT PACK IN CHECKED LUGGAGE

This list is not all-inclusive.

Fireworks:

Signal flares, firecrackers, sparklers or other explosives

Weapons:

Ammunition*, gunpowder, mace*, tear gas or pepper spray*

Lithium Batteries:

e-cigarettes, power banks, spare lithium batteries, devices with a lithium ion battery that exceeds 100 watt hours (Wh)*

Household Items:

Drain cleaners and solvents

Most hazardous materials are forbidden in carry-on and checked baggage. There are a few exceptions for some personal items such as toiletries, medicines, battery powered electronics and assistive devices. Remember, this is just a listing of common hazardous materials; if you don't see your item here it doesn't mean it's allowed in baggage. Check the PackSafe website or call your airline for exceptions.

Compressed Gases:

Spray cans*, butane fuel, pressurized scuba tanks, propane tanks, oxygen bottles, self-inflating rafts, flammable aerosols

Other Hazardous Materials:

Dry ice*, gasoline powered tools, camping equipment with fuel, wet-cell batteries*, oxidizers, corrosives, radioactive materials (including radio-pharmaceuticals), poisons, infectious substances



*May be allowed with restrictions.

Don't Pack Light for your Next Flight



Torch lighters (a.k.a. blue flame lighters, jet flame lighters) contain compressed butane gas expelled under high pressure and are not considered lighters. They are forbidden in carry-on and checked baggage.



One liquid lighter or lighter containing absorbed flammable liquid in the lining (Zippo-type) per passenger is permitted in carry-on or on one's person during flight.

IT'S THE LAW...

Persons violating the Hazardous Materials Regulations (49 CFR, parts 171-180) are subject to a civil penalty of not more than \$78,376 for each violation. In cases involving death, serious illness, or severe injury to any person or substantial destruction of property, a civil penalty may be increased to \$182,877 for each violation. Criminal violations may result in fines and imprisonment of up to 10 years..
