Presentation of Three Greyhound Service Dogs Donated To Veterans & Quilts of Valor Ceremony

West Palm Beach, FL - Please join us for the presentation of three fully trained greyhound service dogs being formally donated to three individuals. Hounds and Heroes (a program of Awesome Greyhound Adoptions, Inc. AGA) is an all-volunteer organization that trains only the retired racers as service dogs and donates them to veterans in need.

One Marine, one Navy veteran and one Federal employee are the recipients of the seventeenth through nineteenth service dogs from AGA. Currently we have three more greyhounds in training and one due to enter the program shortly, making a total of twenty-three that have been through, or are going through, this program. The Palm Beach Kennel Club is highly supportive of this program (begun in May of 2011) and is hosting this event for AGA's Hounds and Heroes.

In addition to the formal presentation of the service dogs to these three individuals, there will be a ceremony by Quilt Guild by the Sea presenting hand made quilts to all our veteran owners over the past few years. Also, representatives of Honor Portraits will be there for a formal photo shoot of the veterans.
